I understand that Camp Blue Ridge and Haymarket Children's Academy employees are bound by contract and not available for full-time employment by enrolled parents. I will not attempt to make regular ongoing employment arrangements. Occasional after-hours care arrangements are acceptable. I have read and understand the fee arrangements, the parent handbook, and the policy statements on this form. I agree with these policies and will abide by them as well as any addendums that may arise after enrollment.

If I should need to withdraw my enrollment during the summer, for any reason including attendance, illness, dismissal, schedule changes, or voluntary withdrawal, I understand that I am financially responsible for the remainder of the Camp tuition. If debt collection services become necessary, Camp Blue Ridge and Haymarket Children's Academy reserves the right to charge reasonable collection costs, including a \$250.00 administrative debt collection fee, for which I will be responsible.

****I further acknowledge that my Camp Blue Ridge registration fee must be paid on the day of registration and is non-refundable. I understand that weekly tuition payments are due no later than close of business on Wednesday. I further understand that if tuition is two or more weeks past due, my child will not be allowed to attend until the account is brought current. I understand that no refunds will be issued for changes or cancellations after May 8, 2026. Payment is required for any and all weeks indicated on page 1 upon submission.**
